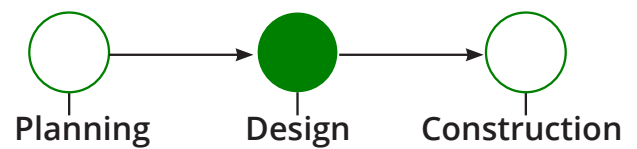
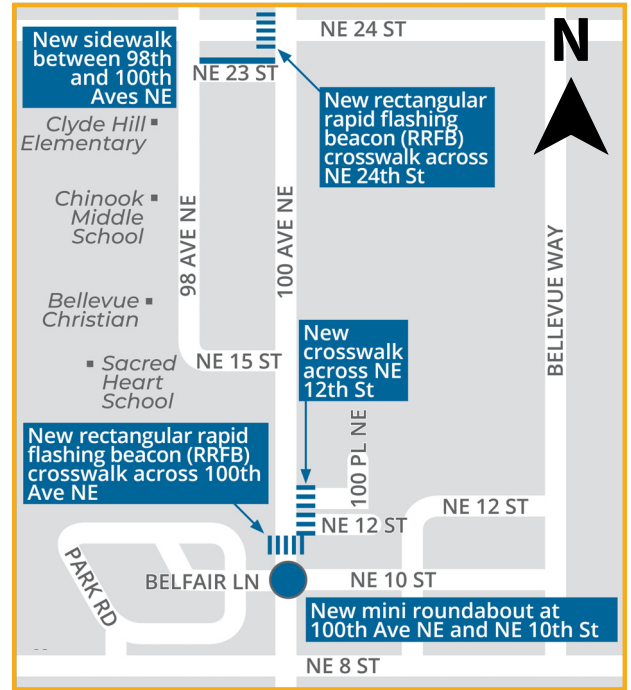
100th Avenue NE Complete Streets Project: Intersection and Pedestrian Improvements

June 2019

Description and benefits

With input from neighbors along 100th Avenue Northeast, the Bellevue Transportation Department is now advancing the following plans to improve pedestrian connections to schools, parks and other neighborhood destinations and to increase traffic safety for pedestrians, bicyclists and drivers.

- Construct a landscape planter separated sidewalk on the north side of NE 23rd Street between 98th Avenue NE and 100th Avenue NE.
- Install a Rectangular Rapid Flashing Beacon (RRFB) system at the crosswalk on NE 24th Street at 100th Avenue NE and improved curb ramps.
- Construct a mini-roundabout at the intersection of 100th Avenue NE and NE 10th Street and upgrade crosswalks with pedestrian “refuge” islands.
- Install a new RRFB crosswalk across 100th Avenue NE at NE 12th Street and improve the crosswalk across NE 12th Street on the east side of 100th Avenue NE.

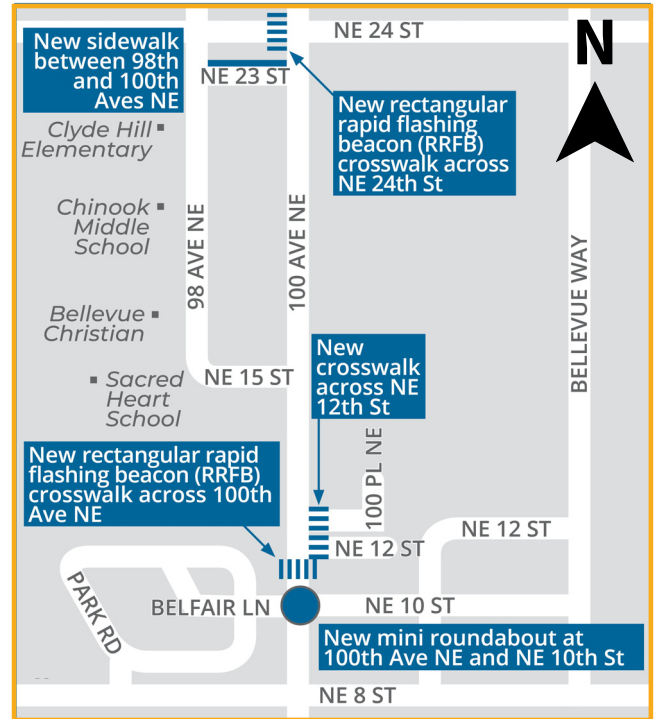
项目更新

100th Avenue NE 完整街道项目： 改善十字路口及行人环境

说明和益处

在 100th Avenue Northeast 的沿路邻居建议下，贝尔维尤交通部门 (Bellevue Transportation Department) 目前正在推进下列计划，以改善行人去往学校、公园和其他附近目的地的通行情况并提高行人、骑行者和司机的交通安全。

- 在位于 98th Avenue NE 和 100th Avenue NE 之间的 NE 23rd Street 北侧建造一个景观种植分隔人行道。
- 在位于 100th Avenue NE 的 NE 24th Street 的人行横道上和改良的路边坡道上安装矩形快速闪光灯标 (Rectangular Rapid Flashing Beacon, RRFB) 系统。
- 在位于 100th Avenue NE 和 NE 10th Street 的十字路口建立一个小型环岛，并升级人行横道与行人“庇护”岛屿。
- 在位于 NE 12th Street 的 100th Avenue NE 安装一个新的 RRFB 人行横道，并改善 100th Avenue NE 东侧 NE 12th Street 的人行横道。

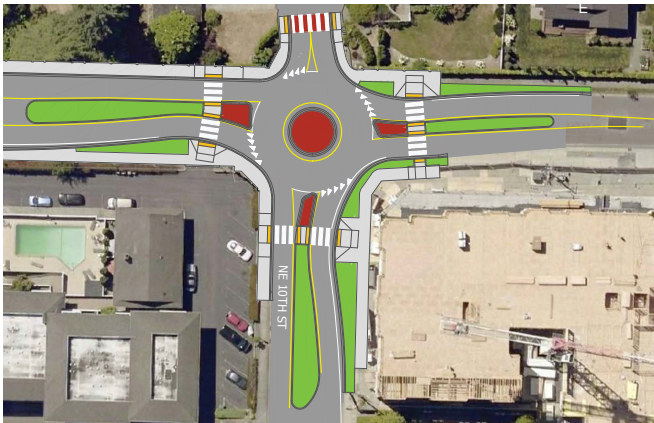

Funding

The City has combined multiple project elements for better coordination and community outreach. Design and construction funding are supported by the voter-approved Neighborhood Safety, Connectivity and Congestion Levy, Water Main and Storm Drainage Improvements, Downtown Livability Implementation and the Downtown Transportation Plan Implementation. Estimated cost: \$1.30 million.

Phase 2: Design is underway for future improvements along a section of 100th Avenue NE and on some vicinity streets. These improvements include sidewalks, a multi-purpose path and crosswalk and intersection improvements. Construction is expected to begin in 2020.

为了更好地协调并进行社区外展，本市结合了多个项目要素。设计和建设资金由选民批准的社区安全 (Neighborhood Safety)、连通性和拥堵税 (Connectivity and Congestion Levy)、给水和雨水系统改进 (Water Main and Storm Drainage Improvements) 市中心宜居度实施 (Downtown Livability Implementation) 和市中心交通计划实施 (Downtown Transportation Plan Implementation) 提供支持。估计成本：130 万美元。

阶段 2：100th Avenue NE 一沿路的一部分和一些附近街道的设计正在进行中，以便在未来有所改进。这些改进包括人行道、多用途道路和人行横道和十字路口的改良。施工预计将于2020年开始。
