## Downtown/BelRed

In June and July, 523 ballots were returned on the 24 proposed enhancement projects to receive Neighborhood Enhancement Program (NEP) funds. Two projects will be funded out of the \$491,000 Downtown/BelRed NEP allocation, which will also encompass associated planning, design, labor and materials fees. Additional funding is being provided for DBR-7 from a partnership with the Parks Renovation budget (CIP PR-11).

The following projects will be funded and implemented by the Neighborhood Enhancement Program over the following three to five years.

**DBR-5**  
**NE 8th St Pedestrian Enhancements Over Interstate 405**  
**\$450,000**                      **442 points**

This project will improve safety for pedestrians crossing the I-405 ramps along NE 8th St by marking crosswalks, adding rapid rectangular flashing beacons (RRFBs) and signaling crossings at select locations. Existing concrete islands will be modified with shortened crosswalk lengths and vegetation. Excess pavement will be removed, and landscaping added to buffer pedestrians and improve the appearance of this important entrance into Downtown and BelRed. *Since the overall project cost exceeds the funding allocation from NEP, other city programs will also support project implementation. Additional funding will be provided from the Enhanced ROW/Urban Boulevards (CIP CD-22) and Downtown Community Development Implementation (CIP CD-37) programs.*

**DBR- 7**  
**Downtown Park SE Corner Stairs**  
**\$56,000**                      **399 points**


This project will construct a new stairway at the southeast corner of the park to allow access to the Promenade from the existing crosswalk. Currently park users are walking up the landscaped slope to enter the park, deteriorating the landscape. New stairs will be constructed of concrete and include a metal handrail.
