

**Neighborhood Leadership Gathering
COVID-19 Community Impact and Response
September 17, 2020**



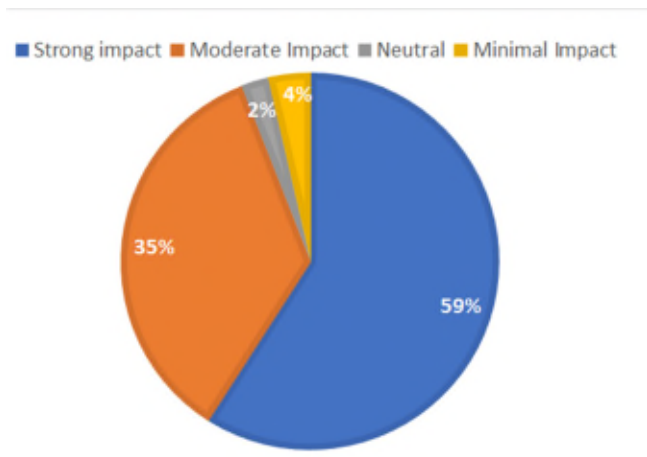
On September 17, 2020, the Neighborhood Leadership Gathering discussed the topic, “COVID-19 Community Impacts and Response”, exploring how COVID-19 has impacted Bellevue’s community and local businesses as well as city response. In preparation for this discussion, the city posted an online survey from September 1-September 14 to hear from the community about how COVID-19 has impacted their daily lives. There were 258 survey responses.

Some of the key observations from the survey results:

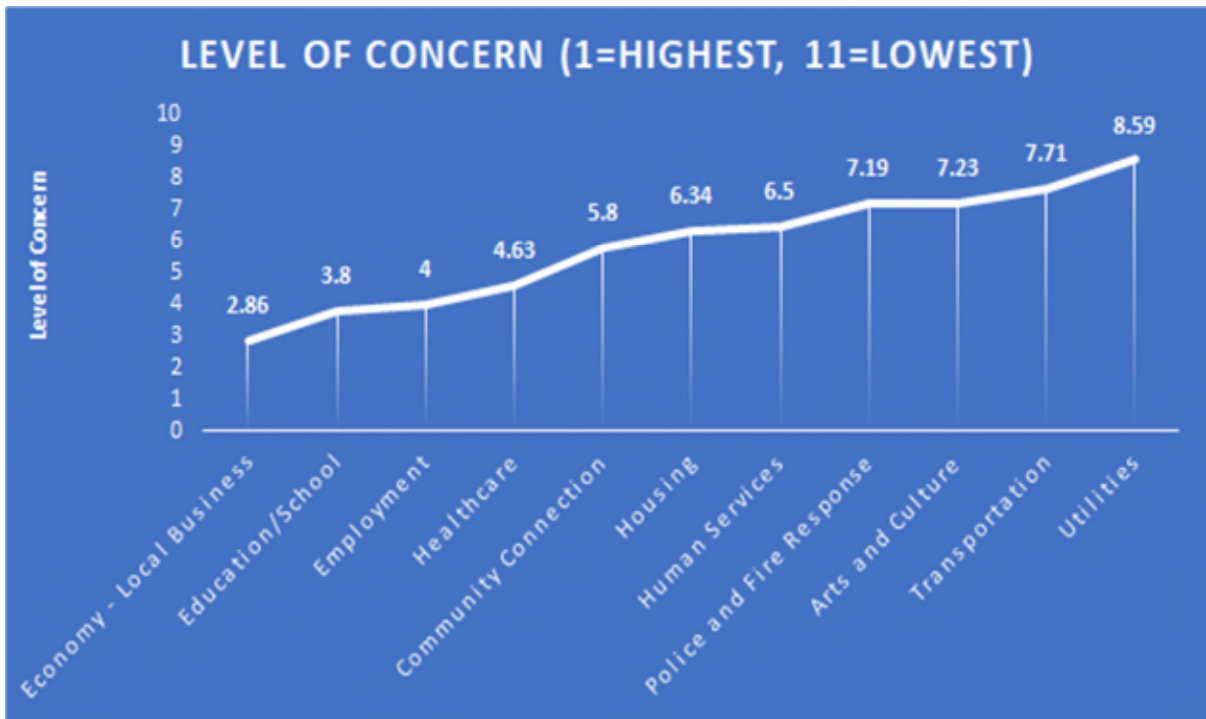
- 1) 94% of respondents have been strongly, or moderately impacted by COVID-19.
- 2) 64% of respondents have experienced a moderate or severe decrease in community connection.
- 3) Nearly half of respondent households (48%) have experienced a decrease of income due to COVID-19.
- 4) One in five respondents are moderately confident, slightly confident or have no confidence in their household’s ability to pay next month’s rent.
- 5) The services that residents have had difficulty accessing include:
 - Financial assistance
 - Food assistance
 - Rent subsidy
 - Unemployment
 - Medical insurance
 - Affordable housing
 - Free COVID testing
- 6) Top 5 areas of concern were:
 - i. Economy – local businesses
 - ii. Education and Schools
 - iii. Employment
 - iv. Healthcare
 - v. Community Connection
- 7) Although 91% of respondents are very concerned or moderately concerned about local businesses – only 30% have increased purchasing from local or neighborhood businesses.

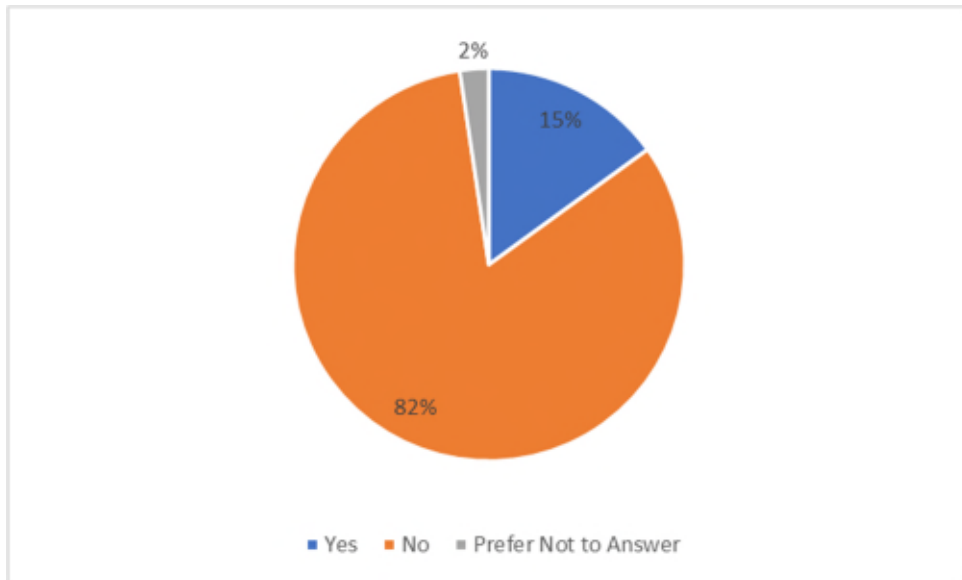
How much has COVID-19 impacted your daily life?



Please rank COVID-19's impact on the following items that have you the most concerned. (1=highest concern, 11 = lowest concern)



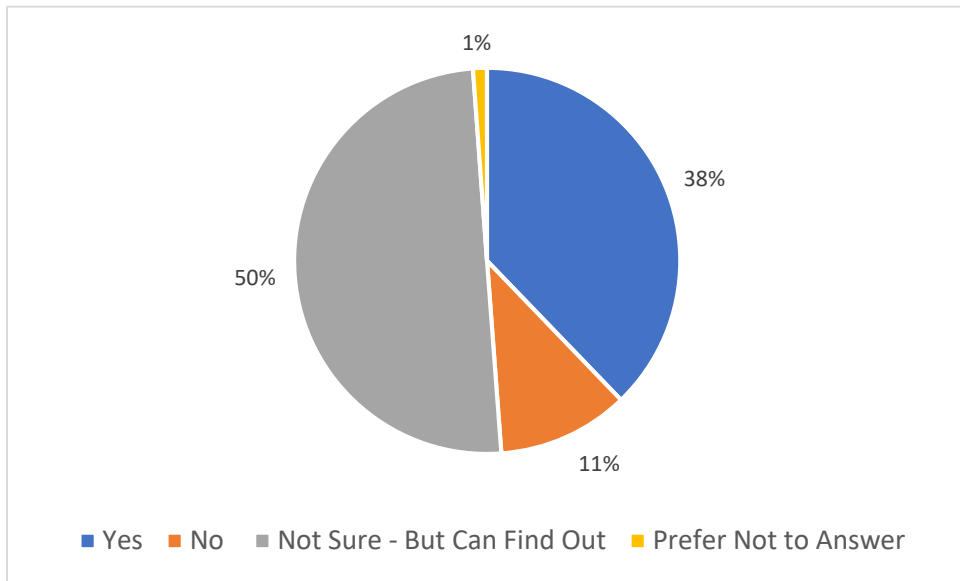
Have you needed community resources (food bank, financial assistance, etc.) during this crisis?



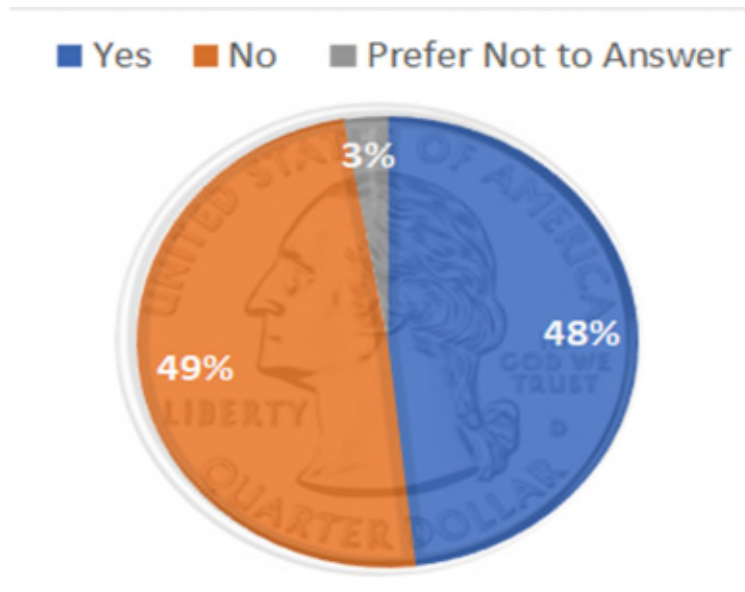
If you had difficulty accessing services, which service and why?

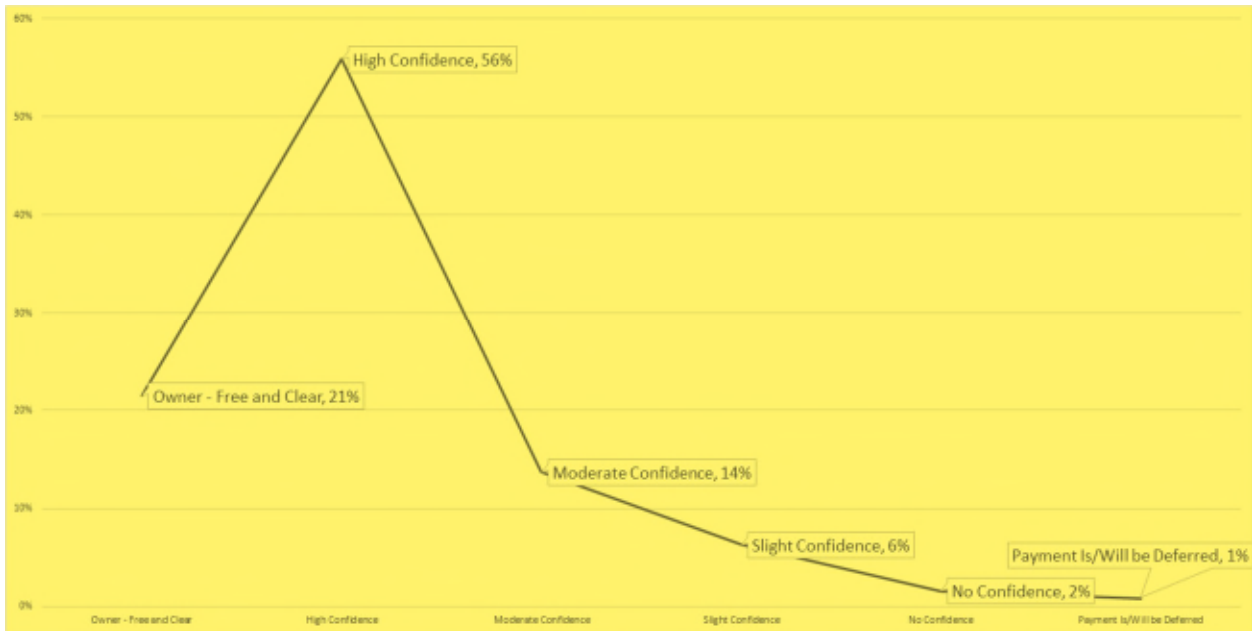
Do you know where to go if you need community resources (food bank, financial assistance, etc.)?



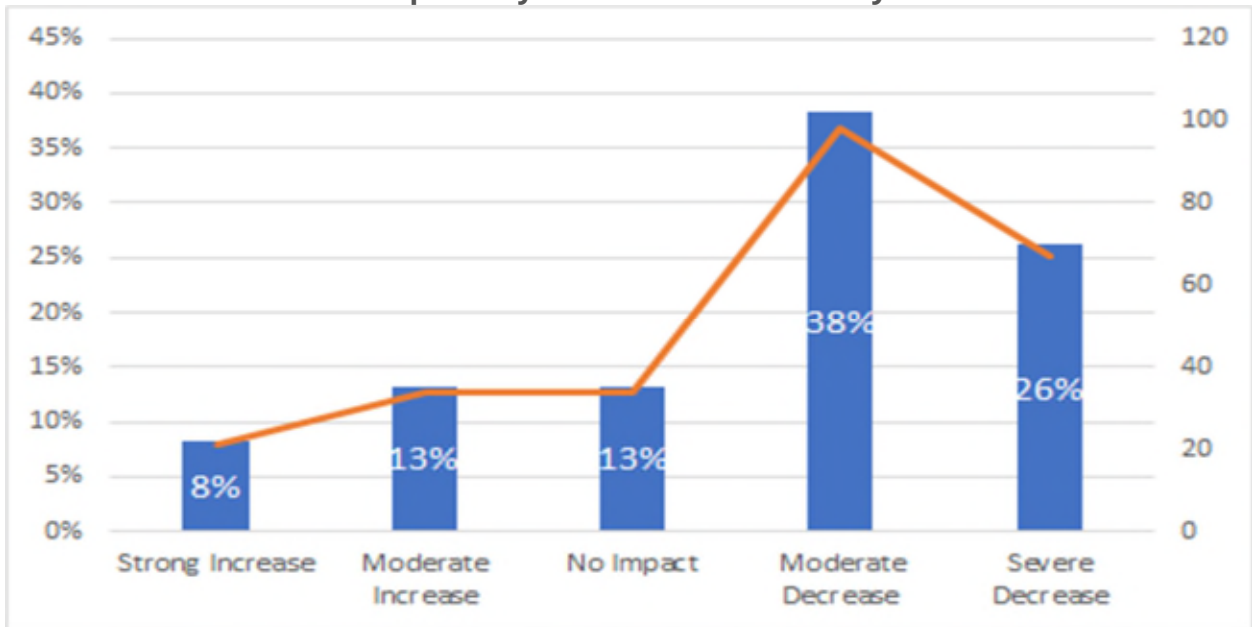
Have you or a member of your household experienced reduced income due to COVID-19?



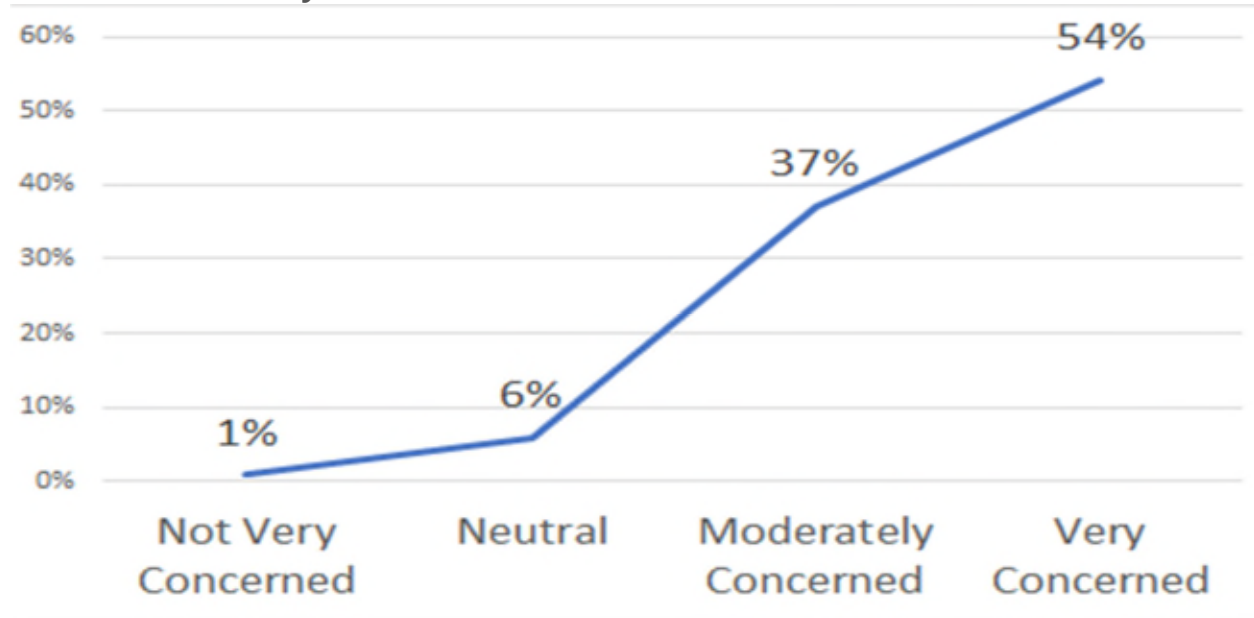
Do you have confidence in your household's ability to pay next month's housing costs?



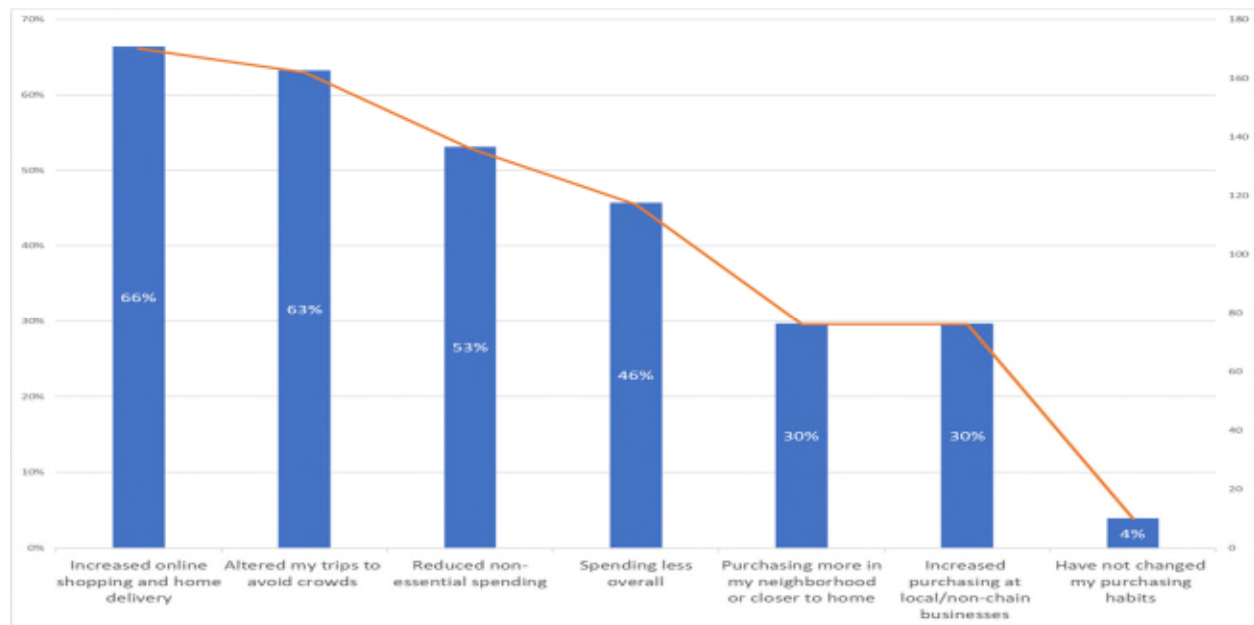
How much has COVID-19 impacted your sense of community?

Written submissions

General comments

- We appreciate what the city is doing and we're all doing the best we can.
- I appreciate the steps the city has taken and believe city government is well aware of the impacts
- Good to see the city set a good example of sacrificing (canceling events and gatherings).
- The impact of Covid is terrible. I can only imagine another disaster at the same time - such as a big earthquake, civil unrest. I can also imagine worse pandemics. Bellevue like other cities needs to be prepared with plans for likely scenarios.
- Thank you for staying engaged and working diligently to support the community and keeping us well informed
- That there is a general lack of concern by many of its citizens.
- Maintain an approach of we're in this together - as opposed to the message from the White House.
- The local response to COVID-19 is very important and meaningful to residents, especially since the state government's response has been inadequate and flawed and the the federal government's response has been reprehensible. Neighborhoods are simmering with stress, and chronic nuisance issues are worsening in my local neighborhood. What I most want to see is long-term investment in community infrastructure and services that can meet the challenges of the whole 21st century. The idea that we'll be 'done' with pandemics after COVID-19 is fanciful; in this overpopulated world, I want to live in a city that can manage pandemics even if one happens every decade. The country as a whole is not following science, whether on disease or on climate change; it falls to Washington state, and to cities like Bellevue, to enact policies and design/redesign infrastructure so that we can lead lives that are inherently social-distancing-capable yet also sustainable.
- It's a crushing blow that could have long lasting consequences and problems. But this isn't news do anyone. Just sad.
- Stop giving away our tax dollars to developers and homeless/bums.

Written submissions

Social distancing and face masks

- Social distancing and face masks have kept me, my family, my friends, and my coworkers from getting sick. Keeping those measures in place as we slowly go back to normal will help others from getting sick as well.
- I'm covid 19 recovery survivor I live in the Landmark apartment here at this community is like another's world 98percent people do not wear mask I do not know why. Even through City and different agency try so hard to give out free masks still people in this neighborhood doesn't wear it. And the Salvation Army during the dinner pick up time start at 5:45pm running until 7pm about 20 percent people wear masks I know the staffs do their best but no rules no mask no service. I wish they do practice that rule of mask or social distance.
- Yesterday I had coffee outside with a friend, social distancing. A group of about 12 teenagers crowded around a couple of tables, no masks, jammed together. How will this get better with such behavior? That said, it breaks my heart that these kids lives are so impacted.
- Not everybody wears a mask
- People are mostly considerate about social distancing and masks
- more needs to be done to enforce social distancing and bolster businesses.
- I have been treating life as if we're in a lockdown since March, barely leave the house, and I don't plan to change until mask compliance is near 100% or there is a vaccine. I feel anger towards much of the community who don't follow mask and social distance guidelines and it makes me feel like I don't belong here and want to leave, since I'm taking things seriously and so many others aren't.
- A friend who lives in Seattle visited me recently here in Downtown Bellevue for a socially-distanced walk and he told me lots more people use face coverings in Seattle as compared to Bellevue. I always use one and I was troubled to hear that. Should the city government speak out about it more, or put up more signs?
- Open up more. Either masks work or they don't we don't need both!
- I believe more activities and businesses could have continued if government had trusted people to use common sense and wear masks and maintain social distancing.
- Mask wearing and social distancing must be enforced in all public places.
- Please enforce mask rules so that we can get through this as quickly as possible.
- We need everyone to wear masks in public so we can fight this virus and get back to business, and visiting friends and family.
- Keep your mask on and just follow the community rules to not only protect yourself, but the entire community.
- The more people don't take social distancing, masks and lock down seriously the longer this will drag out. It will affect everyone young and old alike. It's very frustrating to sacrificed my personal activities (friends, concerts, arts, restaurants) only to see cavalier attitudes by so many. On hikes I see groups of people packed together obviously not related, no masked (we put ours on when we get even 30 feet from another person) they will come right next to you with Less than 1 feet distance, I constantly Have to jump off the trail into the forest to give a little distance. Just because we are outside if you have Covid and are 1 foot away breathing heavily it's no different than passing someone in the store aisle. Young people 20's -30's are the worst offenders. I live in Bellevue to be near hiking trails but since March I may as well be over at

Greenlake. I wish authorities would emphasize to residents more to be just as cautious with Covid on a hiking trail as in a public building. Thank you.

Community Connection

- It's really hard to be new to the community with such limited opportunities to connect, make friends, and enjoy activities. Especially difficult for my teen.
- Our little neighborhood of Collingwood appears to be taking it in stride but there are families that we rarely see or interact with so it's hard to really know.
- The tremendous isolation the older residents are experiencing.
- It has been very hard for all ages 😞
- Concerned about so many things: people's livelihoods being affected. Senior members whose lives are isolated...children's education limited..
- Our family was impacted by Covid just before the start of the school year, glad we were not infecting others and isolated at home.
- 孤寡老人 (lonely old man)
- Miss community gatherings. Festivals. Feeling extreme isolation. Tired of being hooked to a computer.
- The pandemic has exacerbated social isolation and divisions. We need leadership and opportunities to rebuild connections and a sense of belonging among all residents, especially those most marginalized and disadvantaged by the pandemic.
- I have not been able to attend meetings that I normally attend.
- I worry about my kids keeping their social skills, especially my six year old who has high-functioning autism
- You don't have to contract the actual virus to suffer from COVID-19. A friend of mine died from sheer loneliness during this pandemic as she was fighting cancer and grieving the loss of her husband when the lock-down started. She was cut off from her entire support network. The social impact of this pandemic cannot be measured but is becoming apparent - violence is up, vulnerable people cannot access the care they need, kids miss their friends, teachers miss their students, parents miss adult time, moms are tired of cooking every meal, trips to the grocery store have to be planned, we miss going on hikes and visiting the beach (both have become too crowded), when will we see our parents again? When will new grandparents get to see their new grand babies? etc. Do we really need to keep our outdoor playgrounds closed and have picnic tables off limits? Zoom and the like are great but they do not replace in-person visits/meetings.
- We can't freely get together with friends and neighbors so it definitely takes more effort to maintain relationships and avoid isolation. However, most people that I know have been cooperative and are doing their best to comply with the guidelines because we know that the more we can pull together and sacrifice for others, the sooner we can have things return to the new normal.
- Covid-19 restricts residents from being able to interact with the entire community in a major way.

- Bellevue residents have been responsible and doing their part during this difficult time. Thanks to everyone who is working hard and keeping safe. I am concerned about the elderly in Bellevue and their health but also their connections with others. I would often visit my elderly neighbors and stop by every other week to check on them or have a coffee. But with the virus I am

concerned the elderly are lonely or lacking connection with others. I am not sure what the city can do but I do hope helping the elderly feel connected to the community is part of future city cultural agendas.

- The government's response has been horiffic and damaging to our community. We aren't supposed to go to church. People no longer socialize. Our kids can't play on the playground. It's terrible.

Public Safety

- Mail theft. It started in late June and continues to happen in our neighborhood. We have repeatedly reported this to Bellevue Police. We continue to find dumped mail on sidewalks and at the trailheads. We had mail dumped in our neighborhood from Kenmore. I have had 2 incidents where my credit cards that were sent in the mail by banks (due to expiring cards) and 6 fraudulent charges on my credit cards. I tried to explain to the police that credit cards used at Auto Repair Shops in Burien and Tukwila have been charging credit cards. But yet this still continues to be problematic. I worry about our upcoming election, as the mail theft from Kenmore were primary voter ballots.
- Our city needs to provide us with public security and enough policemen to protect us.
- To keep a strong support of our firemen and medical workers. They need to know we all appreciate the wonderful long hard work they are doing. I know, I lost my husband due to the virus the first part of April and had to call 911 to take him to Overlake Hospital. Everyone was so wonderful and helpful. Even received a call from the Bellevue Fireman Chaplin to see how I was doing and if I needed any help. Very thoughtful call.
- I see a lot of PPE on the ground, in the gutters, and stuck in planters. I try to clean up and properly dispose of what I can. A keep Bellevue clean initiative would be great. Also abandoned shopping carts are all over downtown Bellevue. It also feels like a lot more vagrants are hanging around the downtown area. It's concerning as I want to continue to feel safe while out walking. I also enjoy a clean downtown area. Our city being practically empty for such a long while has that slightly abandoned feel. I'd like to see that change as safely as possible.
- Pay close attention to public safety and medical service
- Racial equity and police brutality must matter after the pandemic is over, not just because we are stressed and trapped at home with time to pay attention.
- We really appreciate our policemen, firemen, and all the first responders who stay focused on the job and support the city and local community. Kudos to you all! We are worried that some are using Covid-19 as the excuse to attack a specific group of the community. Most Asian and Chinese are good supporter of the community and yet being targeted. We worry about our community safety. Police force are very helpful to catch the crime. But we need to have some way to prevent these malicious and targeted crime from happening. We'd want to know how the city has been planning for such.
- Trust is breaking down. I have hope that an eventual transition in leadership will address the breakdown in norms yet this breakdown has forced the acknowledgment that systematic racism must not continue. BLM has correctly identified that the root causes of systematic problems have an economic basis. The breakdown in norms has allowed for a new dialogue which exposes hypocrisy at many levels of our culture which is the only way for our society to rebuild trust over time.

Racial discrimination

Human services

- Offer more financial assistance, rental subsidies, food vouchers (Seattle did it)
- People who are living on the streets really need to be better protected. Minorities in Bellevue also need additional protections so they can prevent the disproportionate spread.
- Many self employed people are impacted and have no recourse (not eligible for new City grant program, can't get PPP, etc.) We are the ones suffering e.g. personal trainers, hair stylists, airbnb operator, housecleaner, etc.

- There is just so much stress. About everything. This takes a toll, on all of us. Community Mental health services are stretched thin, and are a vital resource that must be supported. Please find a way to increase support/resources for community mental health. Thank you.
- Keep supporting or at least do not hinder the operation of charities such as Jubilee Reach and Hopelink, and protect the right and action of safe peaceful protests.
- renting payments
- Many in my neighborhood are TERRIFIED that City services are going to decrease.
- With diminished Financial resources people may struggle to cover basic costs such as food and utilities
- A place of safety and shelter
- 为华人社区提供翻译员 (provide translators for the Chinese community)
- Que me preocupa cuánto tiempo me quedará para que me sigan dando Desempleo hasta que mi empleador me llame para trabajar ya que no tienen fecha para que regresemos, y estamos en espera para que nos llamen. (That I am concerned about how long I will have to continue giving me unemployment until my employer calls me to work since they do not have a date for us to return, and we are waiting for them to call us.)

- I see the impact on families through my work in Bellevue. People are scared, lack of food and unable to pay rent.
- Social divides are being amplified. How will those who have lost jobs find new, safe, living wage employment.
- It is vital that we protect the most vulnerable - those who are vulnerable to COVID-19, and those who are vulnerable to the economic downturn. Getting, and keeping, the infection rate low so that children can return to school, especially children with special needs.
- We need you to focus on all populations, all ages!
- Spring cleaning donations (hard goods) are not reaching those in need. There needs to be a bulk collection and distribution method - this is an untapped community investment/benefit.
- Take care of the homeless and struggling families of color
- Human Services cont.
- More needs to be done to support people experiencing homelessness and people of color (ie. black and brown people)
- Loss of employment for many people.
- Those of us with conditions such as depression need society to get back to normal.
- I am very distressed by the inability of family and support people to visit the sick. Family support is crucial to the improvement of people's condition. Permanent damage has been done to families by people dying alone, etc. people's medical tests were delayed and their cancer is now inoperable. We have concentrated all our attention on one small aspect of a very complex society and have caused untold damage and distress!!! We need to balance ALL the needs of society not just one!!!

- Looking forward, Please be prepared for the launch of vaccines. Make sure distribution and access are well-planned. For those who choose to be vaccinated, help them navigate the system, execute your plans efficiently and soundly. Most importantly, based on science, take a leadership role in achieving buy-in from Bellevue residents.
- I would like to know how many from Bellevue have been infected. I would like more statistics on Bellevue. As of now, I've been told there are no statistics that I should go to the state website which is broken down into counties.

Support local businesses

- Businesses need help! Especially those most impacted by closure. Our relies on music in the schools, and live music performance and rehearsal (we repair band instruments). With all of that shut down, we have almost nothing left.
- As long as government prohibits live music, we need to forgive the rent that's due from professional performers, and we need to forgive the mortgages and taxes of the landlords that rent to them.
- I'm especially concerned about the survival of small local businesses, including restaurants, that are so important to the economy and character and diversity of the city. I live and own a small business in Bellevue that has been significantly affected. We're still hanging in there, at reduced capacity/income/profit, thanks to a federal PPP loan/grant and a smart and generous landlord who was able to cut us some slack during the 3-month total closure, but we're on the precipice. So many local businesses are.

- That it's really important to keep small business afloat and eventually vibrant again.
- I'm concerned both about the potential loss of local businesses AND about the impact of all the excess plastic waste generated by the increase restaurant takeout. Is City of Bellevue increasing options for outdoor seating, as Issaquah and Edmonds have done?
- Look for ways to encourage shopping (online or in person) in Bellevue. Promote human service organizations helping Bellevue families get through the pandemic. Look for ways to partner with the school district to reach broader community.
- I'm not going into businesses unless i need food or household goods. Would never forgive myself if I bought some non essential thing and hurt someone else.
- We need to help the small businesses.
- Need to make plans to restart vitality of neighborhoods and commercial areas
- How worried we are about local restaurants and small businesses
- Some items are difficult to get on line, and local retail stores are either out of stock, or forcing people to come into their store to purchase them, thus putting them at risk of getting infected with Covid-19. For example Sanitizing wipes, like Lysol and Clorox.
- We know so many people who have experienced job loss or diminution - let's actively find ways to assist
- For residents not in the tech industry or other high-paying jobs, job uncertainty is real. I've cut back my non-essential spending as I'm worried about keeping my job and with the high cost of rent, need to be as conservative as possible. Also, supporting local businesses and ensuring our restaurants and retailers can make it is key, especially in Downtown where many workers won't be returning in the near future.
- Left my job located in Bellevue that I worked at for 11 years to stay home and care for my kids. Many are having to do the same.
- On June 30 we lost a decades-old business (Lee's Martial Arts) that serves kids and adults. It could not survive without in-person classes. July/August are traditionally their slow months and they rely on the revenue from March-June to survive the summer. We are heartbroken. LMA had a long history of building up kids physically/emotionally/mentally, and of being a great partner with the community club. They were also closely connected to other businesses, as parents who were waiting for classes to be over often visited Resonate or Mustard Seed for a drink, or picked up food from one of the 5 neighborhood restaurants. 2. Negative: A lot of people in the neighborhood have turned into "Karens", reporting others to BPD and on social media for perceived violations of the governor's mandates. All of a sudden we have a bunch of "Mrs. Kravitzes" watching out their windows to report people walking together or playing at the park who they know nothing about- sometimes the people have responded on social media to say "that was me, and I was walking with my family!" In general, the divide over COVID has created a lot of incivility on Nextdoor.com. Newport Hills is connected to 44 other neighborhoods in South Bellevue, Newcastle, and Renton. It's appalling how quickly COVID-related discussions turn ugly and what people are willing to say to/about each other from the security & anonymity provided by a computer monitor. #keyboardjerks 3. Positive: Newport Hills has always been a very pedestrian & bike-oriented neighborhood. Walking & biking increased immediately following lockdown and has continued to increase as the weather improved. It's been great to meet new people as they walk by my house. Also, we've had some really great resident-driven community offerings spring up, like The Giving Tree (drop-off/pick-up items for kids) organized by neighbor PatAnn Robinson, and Teddy Bear Hunt & virtual Egg

Hunt (bears & paper eggs placed in windows for kids to look for while passing by). We held our first neighborhood vehicle parade with over 30 participating vehicles celebrating graduations, Black Lives Matter, community pride, local businesses, and more. Also, with all the large auto shows cancelled this summer our weekly Wednesday cruise-in at the Newport Hills Shopping Center has seen a HUGE surge in the # of vehicles attending, which has exposed many new people to the wonderful businesses in our commercial district (usual avg weekly attendance= 21 vehicles; 2020 avg weekly attendance= 35 vehicles; high 2020 attendance= 62 vehicles).

- You have taken the best steps you could to support restaurants outdoor dining and takeout services. That's great, and I can't imagine what more you could do! But it may be insufficient to save many of them.
- Please re-open slowly and responsibly. I want to get back but don't want to get sick again.
- Open up safely and soon.

Parks

- Parks are very confusing. The signs are put up and taken down daily. We don't know if we can use the Evergreen Park on 164th by Phantom Lake.
- Definitely been going out less and spending less time interacting with other people. Spending a lot of time at home, doing home projects and working from home. Having delivery and e-commerce ordering more frequently to supply what we need.
- Outdoor activities should not be restricted
- 公共地方的清潔 公園應該維持有洗手間和洗手的地方 (The cleanliness of public places Parks should maintain a place with toilets and hand washing)
- Please fix the libraries and please get them open. Also don't shut down parks again. Super annoying
- Is there any way to open more facilities and activities at community centers? If not, is it possible for city to provide variety of online classes or activities such as kids' computer classes like how to create games, videos and animations, DIY classes, cooking classes, workout classes...etc.?
- At this time, I haven't gone back to any of the city park or outdoor activity.
- No access to playgrounds is huge on families with kids.
- Parks and playgrounds need to reopen
- One of the many overlooked impacts. With schools being remote and all other events canceled (even Garden D'Lights which is months away) there is very little feeling of community.
- I have a question/complaint. I don't want to sound too whiny but being in quarantine since March has made me a little more whiny than usual. We have several community centers in Bellevue that remain shuttered and many Parks employees doing nothing (I'm sure some of the full-time staff are doing something, but the part-time staffers have all been laid off or furloughed or just not called in, and I know personally some of the full-time staff are doing nothing). Why doesn't Bellevue Parks at least offer child care/school help in their community centers this fall? Like the school district? Help out those who can't be home with their kids? There are a lot of gyms, community rooms, and employees that are doing NOTHING right now. I am a contractor with Bellevue Parks as well as a number of other cities around the area. Issaquah Parks is doing just that--using their ONE community center to provide child care and they are even doing after-school activities. Of course the extracurricular classes can only have five kids each, but hey, that's SOMETHING. I was able to hold two camps there over the summer under the child care rules. Bellevue? Nada. As a hefty taxpayer in Bellevue, and as a contractor, I'm getting a little irritated. I can stay home with my kids because my business is mostly

shuttered right now (except for Issaquah, of course). But I know there are a whole lotta parents who don't have that luxury. Seems our city could be doing a little more.

Education/Schools

- Please open schools and business. The cure is worse than the disease. Kids mental health is fragile, businesses are failing. The curve has flattened, hospitals are not over run.
- Closed schools are having a huge affect on our kids and families!
- School Education, Child Care and Support low income family
- No in-person school is going to start having a severe negative impact on our students soon. We need to address quickly options. Also, small businesses may need help strategizing on creative ways to adapt to changed needs.
- Let's get our kids back to school! Let's let businesses open - smartly - ongoing masks, distancing and always people need good hygiene - washing hands, no hugging/touching/shaking hands, etc.

COVID-19 Shutdown

- I'm a healthcare worker, and believe this response is completely overblown. Push Jay to open the darned state already. It's criminal what we are doing to kids and working families.
- You have harmed us, this shutdown was not warranted.

These same employees and managers are the same people who don't realize that we are woken up by garbage and park machinery and blowers early in the morning at 7am. It feels like neighbors' lives do not matter to The City of Bellevue and I would love to work on a win/win solution. We could begin with traffic calming and removing the drums and gongs from inspiration playground that are beat on by late-night park trespassers and kids partying in the closed park, plus by closing the park parking lot at 11pm.

- Lack of patronage. All the growth in the restaurant and bar business seems to be hit hard and probably won't make it. When we do have a vaccine and we can all leave our homes again, I think we'll be met with many empty businesses.
- I hope small business can be reopen ASAP and necessary support can be provided
- I'm not concerned about the big businesses downtown because they have the BDA & Chamber looking out for them, though I am concerned by the # of restaurants that have closed downtown in the past couple of weeks. I think it shows that when Bellevue builds a downtown that shoves out all the small local businesses to cater to tourism and the tech industry then there will be consequences in economic downturns such as this COVID-related one. Mostly I'm concerned about all the small businesses around the city that don't have anyone looking out for their welfare. I've been watching Community Development & Economic Development's updates to the council on the CoB's efforts to support business. All the efforts are aimed at downtown. There's life & businesses outside of downtown!!! I was glad when Councilmember Zahn asked about efforts to help small businesses in the outskirts (read: neighborhoods), but I didn't hear any kind of plan for that. Why did the CoB wait so long to offer the \$5K grant money to small businesses? Lee's Martial Arts in Newport Hills had already been closed for almost 2 months by then because we were about 6 months into the pandemic by the time the offer was made-ugh!!! Yet, Econ Dev's focus has been on getting permits for sidewalk dining for downtown restaurants to increase their ability to serve more customers and stay open. What about the other types of businesses that are still unable to fully open, those who often operate in smaller spaces outside the downtown core? Don't those Bellevue businesses count too????

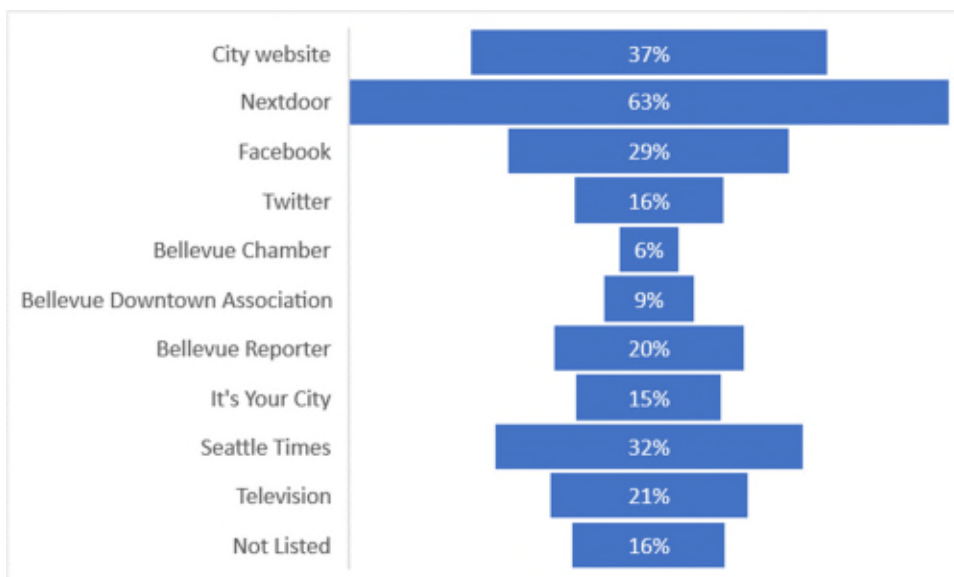
- I am concerned about the number of businesses that cannot survive the lack of customers and the fallout by their employees not earning income.

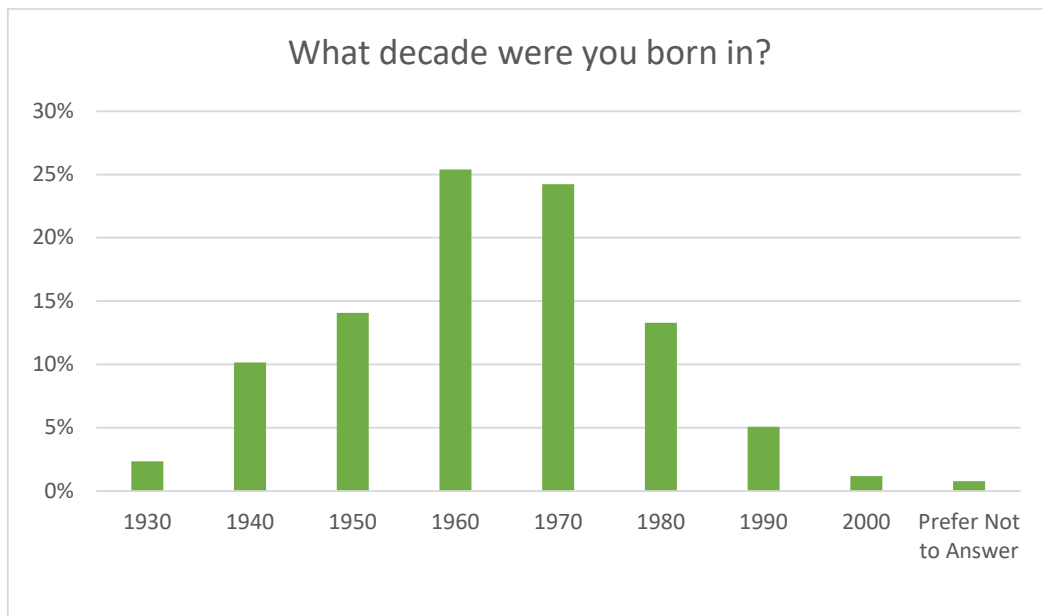
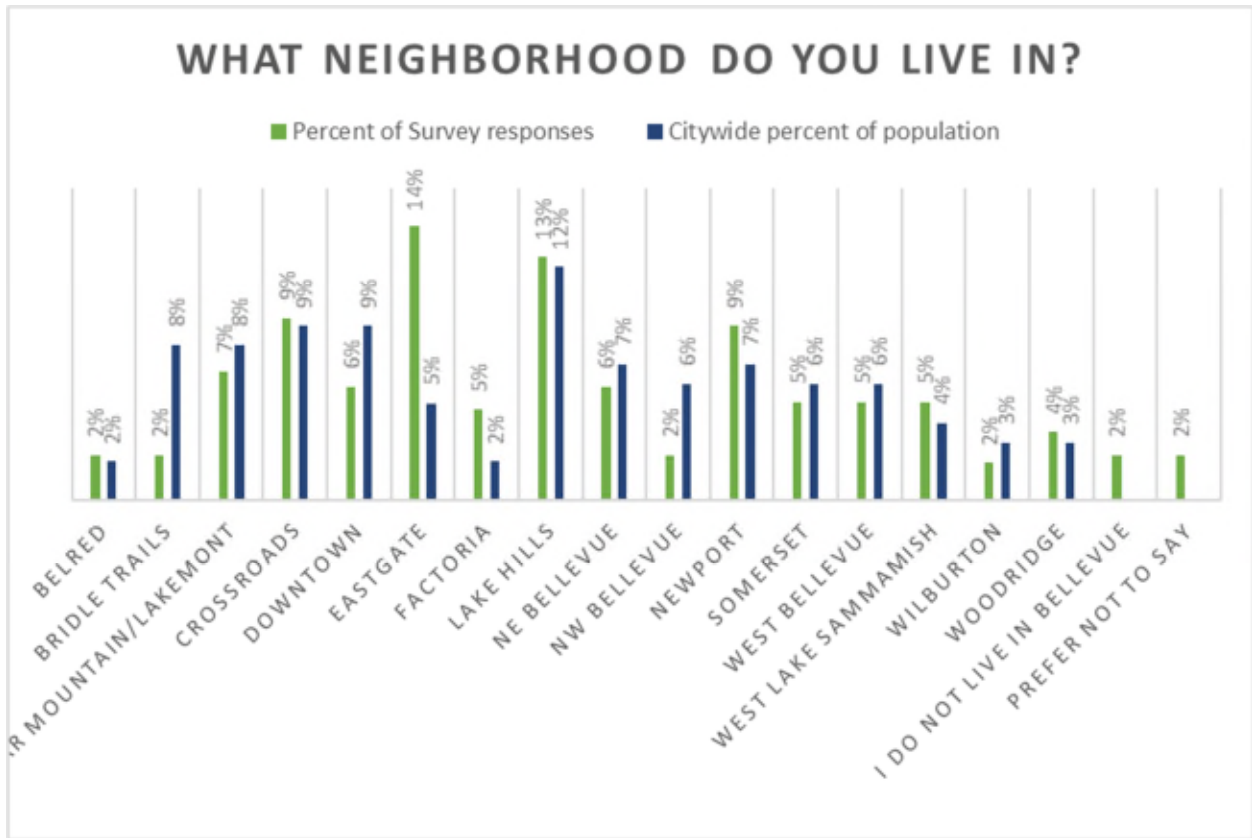
What concerns you the most about Bellevue's local businesses?

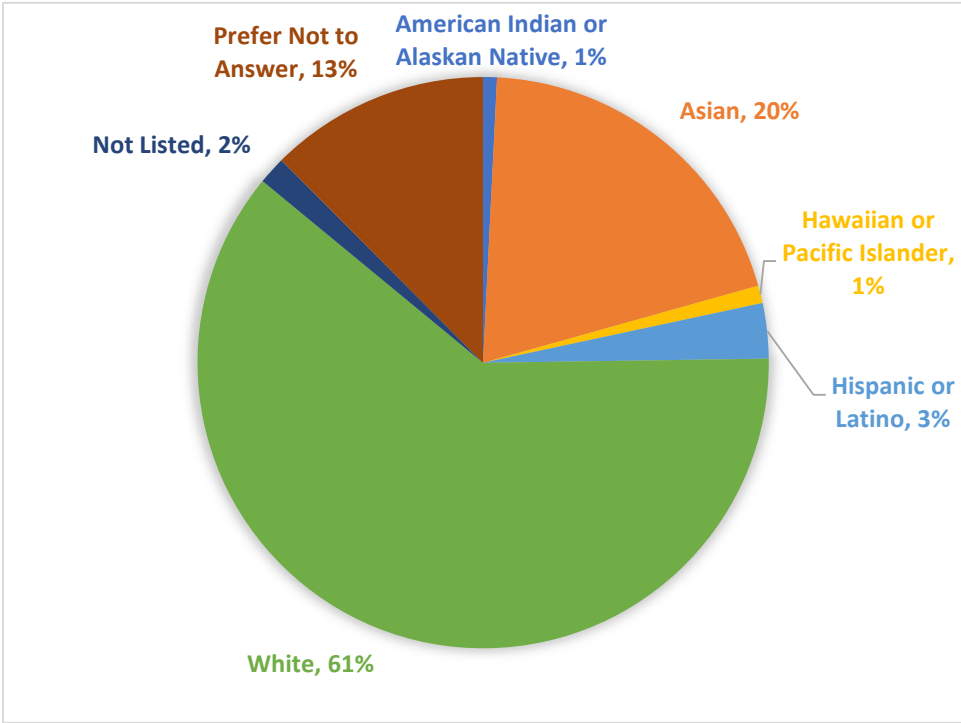
How do you stay informed about the actions the city has taken to support local businesses?
