

REQUEST SUBMISSION DEADLINES – Revised 10/6/2023

Groups may submit request forms for all field use in 2024. You may submit one request form per year, unless separate request forms are needed (see below). For example, if your group's use is April-August, please submit a request for April-August use by the April submission deadline (Nov 15, 2023).

SEPARATE REQUEST FORMS NEEDED FOR:

- 1) **Each Tournament** – Tournament requests should be on a separate request form from regular seasonal requests. If requesting multiple tournaments, submit a separate request form for each one. A tournament offered at different basepath distances should be treated like multiple tournaments.
- 2) **Multiple Basepath Distances** – Request 60, 65, 70, 80, & 90 ft fields on separate request forms. Remember to adjust the participant count listed accordingly.
- 3) **Changes in Participant Count** – Some groups request fields for multiple months, but have participant counts that vary during the year. Please submit separate request forms to document the change in participant count. For example, if the participant count for March and April is lower than for May-July, please submit separate request forms. One form could be for March and April and another for May-July. If easier, consider one form for the March-July teams and another for the May-July teams or one request form for each team.

NOTES

- 1) All Field Requests submitted by Field Organizations received by the submission deadline will be included in the allocation process. The Parks Scheduling Office will acknowledge receipt of the request form, so that groups know it was received. Reminders are usually NOT sent out.
- 2) Requests received after the deadline will be processed in the order received, based on availability following the allocation for that season.
- 3) Requests submitted early will not be processed early or receive a different allocation based on when the form was submitted. If changes in submitted forms are needed, please submit the changes prior to the deadline.
