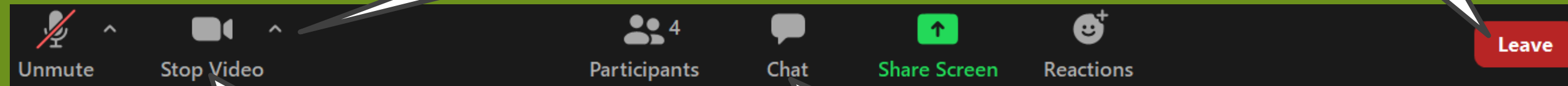

NEP IS...

- **Council-directed, City-Funded, Capital Improvements Program**
- **Provides RESIDENTS the opportunity to PROPOSE and SELECT enhancement projects for their individual neighborhood area**
- **\$7 Million BUDGET distributed among 14 designated NEP neighborhood areas**
- **Area funds allocated based on the number of households in each Neighborhood Area**
- **Rotates through 14 Neighborhood areas over seven-year period – TWO AREAS per year (2023-2029)**
- **Program supported by multiple City departments – Community Development, Parks, Transportation, Utilities**
- **Currently 25 NEP projects in planning/progress around the city in eleven neighborhood areas**



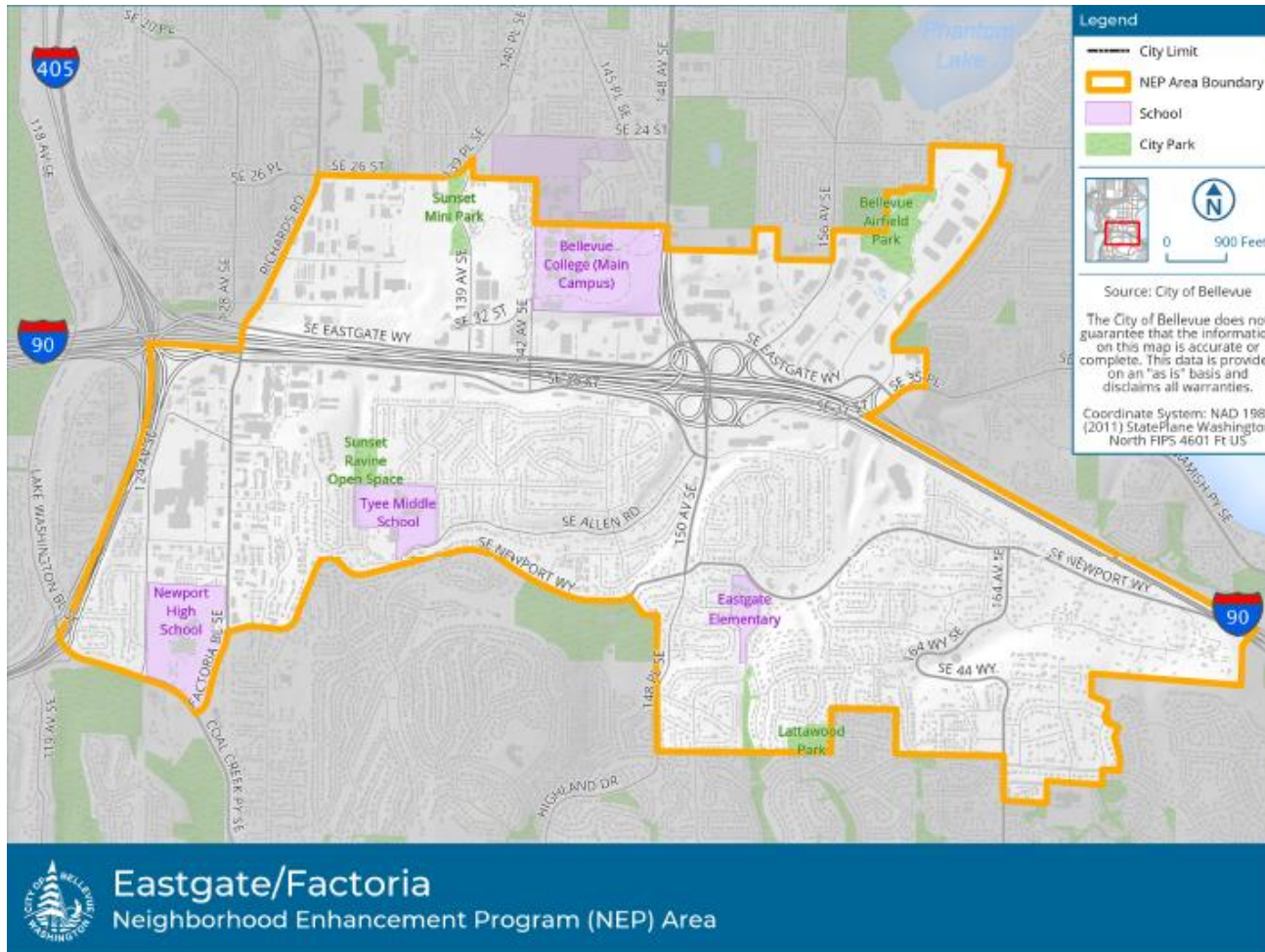
NEP PROCESS

- *City allocates \$\$ to Neighborhood Area*
- *Residents submit ideas for spending \$\$*
- *City staff review ideas & generate projects*
- *Residents select projects to receive \$\$*
- *City implements projects in 3-5 years*

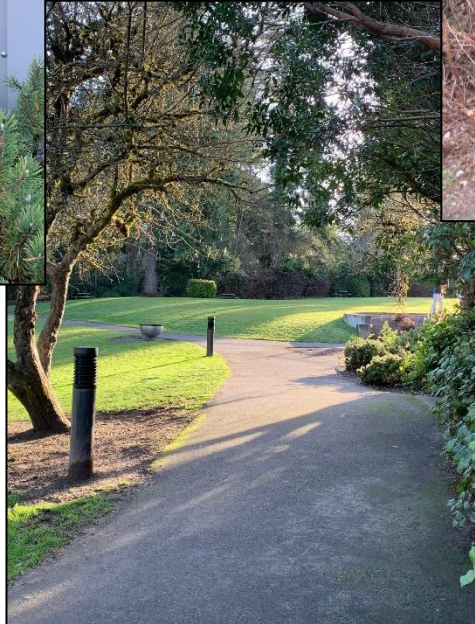
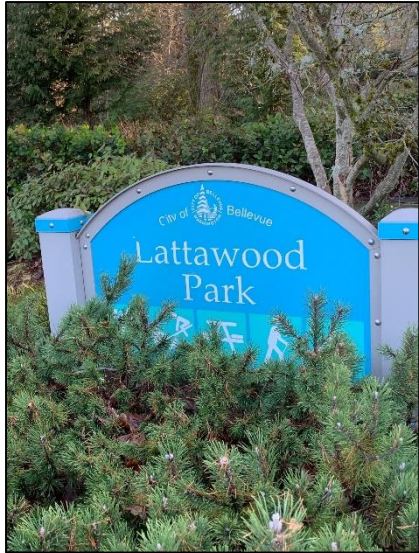

The NEP process will launch in January for the Eastgate/Factoria area, which has been allocated \$370,000 for enhancements.

A virtual kickoff meeting will be held online Wednesday, Jan. 25, 6:30-8 p.m. City staff will provide you with a brief overview of the program guidelines and schedule, answer questions and invite residents to discuss and submit project ideas. Project managers will be available in breakout rooms for specific project discussions. Following the kickoff meeting, each household in Eastgate/Factoria will receive a postage-paid NEP Project Request Form in the mail. Residents are encouraged to use this form, or the online project request form on the NEP website, to submit as many NEP project requests by March 3.

The Neighborhood Enhancement Program (NEP) is a city-funded, capital improvements program that allows residents to propose and select projects that improve their neighborhood's quality of life and enhance its character. The program rotates through the city's 14 NEP Neighborhood Areas, serving two areas each year. In 2023, NEP kicks

PROJECT CRITERIA

AFFORDABILITY

PROJECT COSTS MUST NOT EXCEED THE FUNDING ALLOCATION FOR THE NEIGHBORHOOD AREA

CONSISTENCY

PROJECTS MUST BE CONSISTENT WITH CITY PLANS AND POLICIES

FEASIBILITY

PROJECTS MUST BE PRACTICAL AND ACHIEVABLE FOR THE CITY

IMPLEMENTATION

PROJECTS MUST BE DESIGNED AND CONSTRUCTED WITHIN 3-5 YEARS OF SELECTION

MAINTAINABILITY

PROJECTS MUST NOT REQUIRE MAINTENANCE THAT IS BURDOMESOME TO THE CITY

PUBLIC BENEFIT

PROJECTS MUST BE LOCATED ON PUBLIC PROPERTY, EASEMENTS, OR PROPERTY DESIGNATED FOR PUBLIC USE, AND MUST BENEFIT THE GENERAL PUBLIC
