2023 Outreach Accomplishments

- Updated the Transportation Matrix
- Reordered AARP HomeFit guides, which offers tips/suggestions for retrofitting homes to age in place.
- Committee members continue to monitor the City of Bellevue Weekly Permit Bulletin, Downtown Bellevue Building Updates, and updates from affordable housing advocacy organizations.
