Permits are required for all non-residential and multifamily low-voltage installations. Permits are not required for single family low-voltage installations (*exceptions*: non-residential telecommunications less than 10 outlets).

- ◆ All cabling requires a permit including computer/data (commercial), antenna cabling, telephone systems (commercial), security systems, CATV, fire & stereo systems.
