A RESOLUTION of the East Bellevue Community Council approving City Council Ordinance No. 4854-A, relating to the Comprehensive Plan of the City of Bellevue, as required and adopted pursuant to the Growth Management Act of 1990, as amended, (chapter 36.70A RCW) and as adopted pursuant to chapter 35A.63 RCW; amending the Housing Element of the Comprehensive Plan by repealing Policy HO-20; and further amending Section 1 of Resolution No. 5726, as amended, as readopted by Section 1 of Ordinance No. 4800, and Section 2 of Resolution No. 5726. amending Title 20, the City of Bellevue Land Use Code.

WHEREAS, on the 5th day of February, 1996 the City Council of the City of Bellevue, Washington passed Ordinance No. 4854-A, relating to the Comprehensive Plan of the City of Bellevue, as required and adopted pursuant to the Growth Management Act of 1990, as amended, (chapter 36.70A RCW) and as adopted pursuant to chapter 35A.63 RCW; amending the Housing Element of the Comprehensive Plan by repealing Policy HO-20; and further amending Section 1 of Resolution No. 5726, as amended, as readopted by Section 1 of Ordinance No. 4800, and Section 2 of Resolution No. 5726; and
