

**EAST BELLEVUE COMMUNITY MUNICIPAL CORPORATION

**Resolution No. 459**

**A RESOLUTION of the East Bellevue Community Council approving City Council Ordinance No. 5459 declaring an emergency to allow adoption of certain amendments to the Comprehensive Plan outside of the 2002 or 2003 annual amendment process; relating to the Comprehensive Plan of the City of Bellevue, as required and adopted pursuant to the Growth Management Act of 1990, as amended (chapter 36.70A RCW); adopting an amendment initiated in 2002 to Comprehensive Plan policies related to Wireless Communications Facilities, amending the Utilities Element of the Comprehensive Plan, to balance the increasing demand for wireless services with the impacts of wireless facilities on surrounding properties and uses.**

WHEREAS, on the 4th day of August, 2003, the City Council of the City of Bellevue, Washington passed Ordinance No. 5459 declaring an emergency to allow adoption of certain amendments to the Comprehensive Plan outside of the 2002 or 2003 annual amendment process; relating to the Comprehensive Plan of the City of Bellevue, as required and adopted pursuant to the Growth Management Act of 1990, as amended (chapter 36.70A RCW); adopting an amendment initiated in 2002 to Comprehensive Plan policies related to Wireless Communications Facilities, amending the Utilities Element of the Comprehensive Plan, to balance the increasing demand for wireless services with the impacts of wireless facilities on surrounding properties and uses; and

WHEREAS, the subject matter of said Ordinance falls within the jurisdiction of the East Bellevue Community Council pursuant to RCW 35.14.040; and

WHEREAS, following the public hearing held before the East Bellevue Community Council on September 2, 2003, the Community Council voted to approve Bellevue Ordinance No. 5459;


NOW, THEREFORE, BE IT RESOLVED by the Community Council of the East Bellevue Community Municipal Corporation of the City of Bellevue:
