112th Avenue NE / 108th Avenue NE Pedestrian & Bicycle Improvements **CONSTRUCTION AHEAD**

Installing Bike Lanes in Northwest Bellevue: We will be installing new bicycle facilities in both directions along 112th Avenue NE between NE 12th Street and State Route 520, and along 108th Avenue NE between Northrup Way and the northern city limits, as part of the Neighborhood Safety, Connectivity and Congestion Levy. To provide bicyclists with a designated space to ride, the bike lanes will be buffered and separated from vehicles for most of the corridor.

Adding New Pedestrian Crossings: Two new pedestrian crossings with flashing beacon systems will be installed: at NE 14th Street and near Hidden Valley Sports Park. Both crossings will include marked crosswalks, pedestrian crossing signs, upgraded lighting and rectangular rapid flashing beacons (RRFBs).

To improve traffic flow, we will also be adding a new northbound left-turn lane at the intersection of 112th Avenue NE and NE 24th Street.

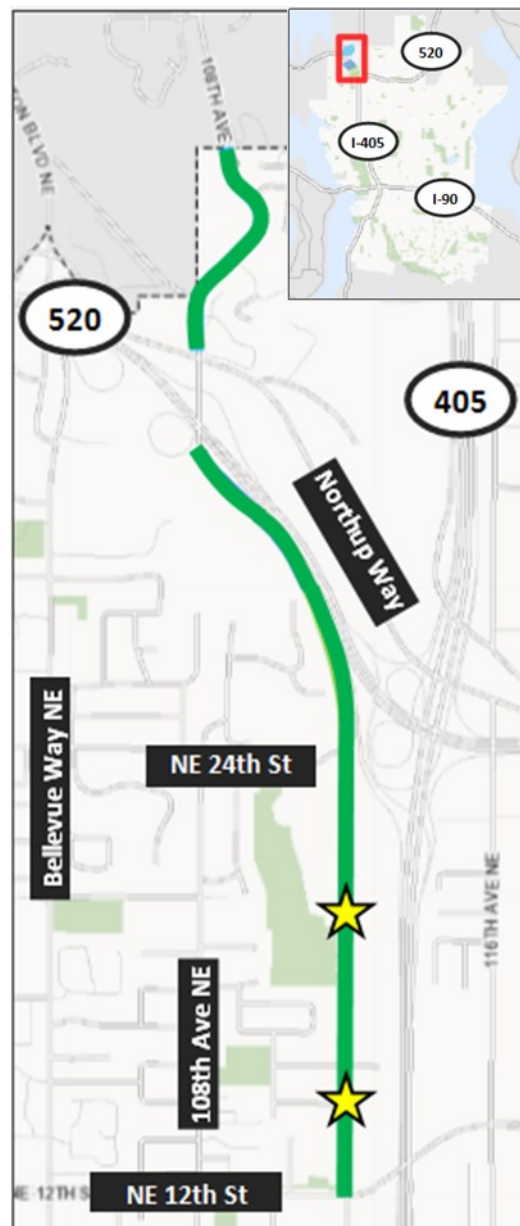
Construction Schedule & Impacts: Construction began mid-September and is expected to be complete by the end of the year, weather permitting. Work hours will be 7 a.m. to 6 p.m. Typical lane closures are scheduled for Monday through Friday, 9 a.m. to 3 p.m.; Saturdays, 8 a.m. to 5 p.m.; and, Sundays, 9 a.m. to 5 p.m. The contractor will be able to work up to four weekend days to complete specialized work.

Please note: During construction, the contractor will maintain access to driveways leading to businesses and nearby residents.

Construction Safety: Please be alert when travelling through the construction zone, especially if you are bicycling or walking and always obey construction flaggers and posted signs.

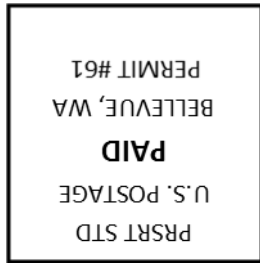


Pedestrian Crossing Location
